Garibaldi Ordinance No. 77 (Enacted 7/12/1972) requires all persons engaged in, prosecuting, or carrying on business for profit in the City must obtain a business license. This includes businesses that are not based within the City who carry out any form of business in Garibaldi for profit. Non-profit businesses are exempt but may be called upon to prove their non-profit status. Garibaldi Ordinance 131 (enacted 3/10/86) requires all solicitors, peddlers, and hawkers to have a City business license and be bonded. License Fees are not pro-rated. Business licenses are good from July 1 to June 30, each year.
