- ***ALL** motor vehicles must provide a copy of a **VALID INSURANCE POLICY** with coverage through July 31, 2025.
- Event staff will review parade rules with every driver during parade line up.
- Absolutely **NO BURNOUTS OR UNSAFE DRIVING** allowed. Violators will be ticketed.
